MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 27, 2006, is made and executed between Donna Y. Knieps, divorced and not since remarried, whose address is 3314 South Sawyer Avenue, Evergreen Park, IL 60805 (referred to below as "Grantor") and Bridgeview Bank Group, whose address is 7940 S. Harlem Ave., Bridgeview, IL 60455 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated December 7, 1999 (the "Mortgage") which has been recorded in Cook County, State of Illinois, as follows:

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property located in Cook County, State of Illinois:

LOT 7 AND 8 IN BLOCK 18 IN B. F. JACOBS EVERGREEN PARK SUBDIVISION OF THE SOUTHEAST 1/4 OF SECTION 2, TOWNSHIP 37 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

The Real Property or its address is commonly known as 9314 South Sawyer Avenue, Evergreen Park, IL 60805. The Real Property tax identification number is 24-02-422-030-0000 & 24-02-422-031-0000.

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

Decrease Interest Rate from Prime to Prime - .50%, Increase Credit Limit from \$105,025.00 to \$150,000.00 and extend the Maturity Date indefinitely (if applicable) until further notice is given. All other terms and conditions remain unchanged and in full force and effect.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all

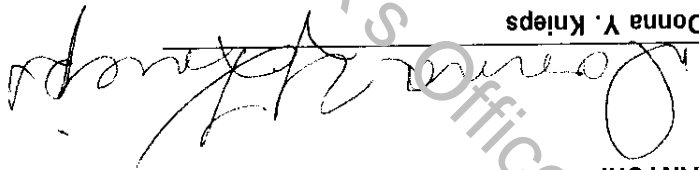

parties, makers and endorses to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

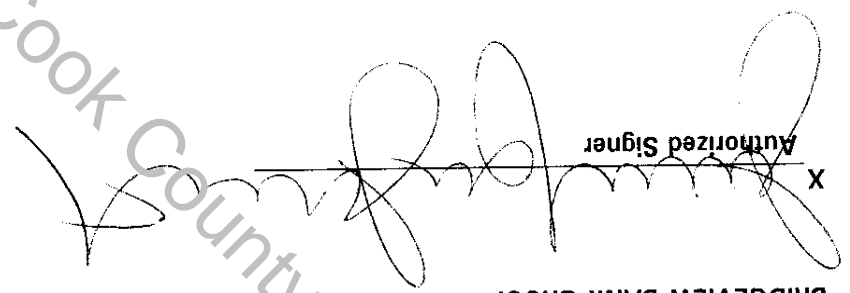

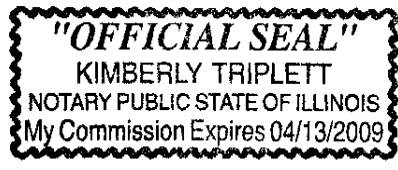
