3. Prior Mortgages; Charges; Liens. You have disclosed to us and obtained our approval of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. - 6. Protection of Our Rights in the Property; Mortgage Insurance. - 15. Sale of Agreement; Change of Loan Servicer. The Agreement or a partial interest in the Agreement (together with this Mortgage) may be sold one or more times without prior notice to you. You shall give us prompt notice of any lapse in required hazard insurance coverage provided by the master or blanket policy.

In the event of a distribution of hazard insurance proceeds in lieu of restoration or repair following a loss to the Property, whether to the unit or to common elements, any proceeds payable to you are hereby assigned and shall be paid to us for application to the sums secured by the Security Instrument, whether or not then due, with the excess, if any, paid to you.

- C. Public Liability Insura ice. You shall take such actions as may be reasonable to insure that the Owners Association maintairs a public liability insurance policy acceptable in form, amount, and extent of coverage to us.
- **D.** Condemnation. The proceeds of any award or claim for damages, direct or consequential, payable to you in connection with any condemnation or other taking of all or any part of the Property, whether of the unit or of the common elements, or for any conveyance in lieu of condemnation, are hereby assigned and shall be paid to as Such proceeds shall be applied by us to the sums secured by the Security Instrument as provided in Section 8.
- E. Our Prior Consent. You shall not, except after notice to us and with our prior written consent, either partition or subdivide the Property or consent to: (i) the abandonment or termination of the Condominium Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the case of a taking by condemnation or eminent domain; (ii) any amendment to any provision of the Constituent Documents if the provision is for the express benefit of us; (iii) termination of professional management and assumption of self-management of the Owners Association, or (iv) any action which would have the effect of rendering the public liability insurance coverage main rained by the Owners Association unacceptable to us.
- F. Remedies. If you do not pay condominium dues and assessments when due, then we may pay them. Any amounts disbursed by us under this paragraph F shall become an additional debt secured by the Security Instrument. Unless you and we agree to other terms of payment, these amounts shall bear interest from the date of disbursement at the rate of interest specified in the Agreement and shall be payable, with interest, upon notice from us to you requesting payment.
