### SCHEDULE A

PARCEL 1

The West 110 feet of Lot 4 in Block 36 in Assessor's 2nd Division in Section 21, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

PARCEL 2

Lots 44, 45 and that part of Lot 43 in Wilder's South Addition to Chicago in the East fraction of the North East fractional quarter of Section 21, Township 39 North, Range 14, East of the Third Principal Meridian, lying South of the following described line: beginning at a point on the East line of said lot 43 being also the West line of Dearborn Street 16 1/2 inches South of the North East corner of said lot; thence Westerly in a straight line to a point 75 feet West of said East line and 16 1/2 inches South of the north line of said lot; thence South Westerly in a straight line to a point 93.7 feet West of the East line and 3 9 feet South of the North line of said lot; thence South Westerly in a straight line to a point 114 feet West of the East line and 7.78 feet South of the North line of said lot; thence South Westerly in a straight line to a point in the West line of said lot, 8, 9 feet South of North West corner of said lot.

PARCEL 3

That part of the North East fractional quarter of Section 21, Township 39 North, Range 14, East of the Third Principal Meridian, being a strip of land 7 feet 2 inches wide West of and adjoining to lots 43, 44 and 45 of Wilder's South Addition to Chicago in the East fraction of the North East fractional quarter of Section 21, Township 39 North, Range 14, East of the Third Principal Meridian, 1971, South of a line 9.7 feet South of and parallel to the North line of said lot 43 extended West, excepting therefrom a triangular place (measuring approximately 1.3 feet on the West line) in the North West corner of said strip conveyed by the Quaker Oats Company to the Hillingis Central Railroad Company, the Chicago Burlington Company, and the Michigan Central Railroad Company, by deed dated August 7, 1915 and recorded August 27, 1915 in recorder's office of Cook County, Illinois, as Document 5699348.

PARCEL 4

Lot 13 (except the North 5 feet thereof), Lots 14, 15, 16, 17 and 1 of 18 (except the North 5 feet thereof) in Wilder's South Addition to Chicago in Section 21, 10 waship 39 North, Range 14 East of the Third Principal Meridian in Cook County, Illinois.

PARCEL 5

That certain strip of land lying between Lots 13 and 18 aforesaid described as rollows: Commencing at the South East corner of said Lot 16, running thence North along the East line of said Lots 16, 17 and 18 to the North East corner of said Lot 18; thence East to the North West corner of Lot 13; thence South along the West line of Lots 13, 14 and 15 to 16th Street; thence West along the North line of 16th Street to the place of beginning (except therefrom the North 5 feet); said strip was formerly a public alley but was vacated by an order of the Common Council of the City of Chicago by unanimous vote of April 11, 1870, all in Wilder's South Addition to Chicago, in Section 21, Township 39 North, Range 14 East of the Third Principal Meridian in Cook County, Illinois.
