- B. Pursuant to the Existing Credit Agreement and subject to the terms and conditions as set forth therein, the Assigning Lenders have made various extensions of credit to the Borrower.
- C. As of the dar, hereof, the Assigning Lenders have assigned to Assignor their rights and obligations under the existing Credit Agreement, including all of the loans and other extensions of credit made by their increment, and Assignor and SBA Properties, Inc. have amended and restated the Existing Credit Agreement pursuant to that certain Amended and Restated Loan Agreement, dated as of November 18, 2005 (the "Credit Agreement").
- D. In connection with the Credit Agreement, Assignor, as agent for itself and for the ratable benefit of the Assigning Lenders, is the incider of those certain mortgages described on Schedule I attached hereto (the "Mortgages") which Mortgages encumber the property more fully and particularly described in the Mortgages and on Exhibit B attached hereto.
- E. In connection with the Trust and Servicing Agreement dated as of even date herewith among Assignor, Midland Loan Services, Inc., and Assignee, Assignor desires to assign the Mortgages to Assignee.

Without limiting the generality of the preceding sentence, Assignee shall have the sole and exclusive right and authority to do any of the following, all in accordance with and pursuant to the Creak Agreement and the Mortgages: (a) exercise the power of sale or foreclose under the Mortgages; (b) exercise any rights and remedies under the Mortgages; (c) agree to any modification, amendment restatement or supplementation of the Mortgages; (d) assign or release the Mortgages; or (e) take or omit to take any other actions as holder of the Mortgages.
- 2. This Assignment may be executed by one or more of the parties to this Assignment on any number of separate counterparts with the same effect as if the signature thereto and hereto were upon the same instrument, and all of said counterparts taken together shall be deemed to constitute one and the same instrument.


