and Donald Cameron, born September 14, 1942. Both of these children are alive.

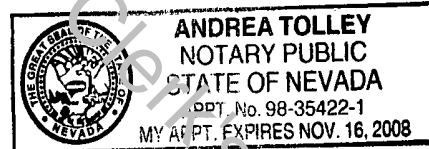
6. No children were adopted by the Deceased and Alice Lee Cameron.
