## AFFIDAVIT OF HEIRSHIP

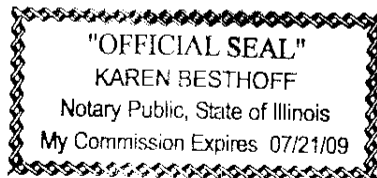
I, MELVIN S. MARKSON, being first duly sworn upon oath state the following:
