This Amendment is reade and entered into this 18th day of 2006 and is an Amendment to that certain Declaration of Condominium Pursuant to the Condominium Property Act for the Boardwalk Condominium Association ("Declaration").

#### WINDESSETH:

WHEREAS, the Board of Directors and Owners of the Boardwalk Condominium Association ("Association") believe it to be in the best interests of the Association to amend the Declaration; and

WHEREAS, pursuant to Section 17 of the Declaration, the Declaration may amended by an instrument in writing setting forth such charge or modification, signed and acknowledged by all the Members of the Board, at least seventy-five percent (75%) of the Unit Owners and containing an affidavit by an Officer of the Board certifying that a copy of the Amendment has been mailed by Certified Mail, to all Mortgagees having bona fide liens of record against any Unit, not less than ten (10) days prior to the date of such affidavit; and

WHEREAS, said Amendment has been approved by Owners having seventy-five percent (75) of the total vote, their signatures attached hereto; and

WHEREAS, the Amendment has been mailed by Certified Mail, to all Mortgagees having bona fide liens of record.

NOW, THEREFORE, the Association hereby declares that the Declaration be and is hereby amended in accordance with the text which follows (Additions in text are indicated by <u>underline</u>; deletions by <u>strike outs</u>):

### 1. Article VIII (w) of the Declaration shall be amended as follows:

Until such time as all units have been sold, the sole and exclusive right is hereby reserved to the Developer to grant to any unit owner, his heirs, successors and assigns, the exclusive privilege to use on or more portions of the enclosed or cutdoor parking area for the parking of one or more automobiles; provided, hover er, that each unit owner who is granted the exclusive privilege to use a portion of the enclosed parking area (or his assignee, if such privilege is assigned as herein after provided) shall pay to the Board, or as it may direct, the sum of Five Dollars (\$5.90) each month in advance for each enclosed parking space which such unit cwher has been granted the privilege to use as aforesaid. Said sum when paid shall 'jec ame part of the maintenance fund. Said parking charge, and any monthly payment thereof, if not paid when due and until so paid by the respective unit owner shall constitute a lien on the interest of such unit owner in the property, which lien may be perfected and foreclosed in the manner provided in Section 9 of the Condominium Property Act with respect to liens for failure to pay a share of the common experses. Any grant of one or more parking spaces to a unit owner shall not be changed and shall be a privilege running with the respective unit ownership.

A unit owner who has been grated the right to use one or more parking spaces shall have the right (with the prior written consent of the holder or holders of any mortgage or trust deed on the unit of such unit owner) to assign in writing the exclusive privilege to use any such parking space to any other unit owner, and such assignee shall, upon delivery of a copy of such assignment and consent to the Board, succeed to all of the duties, obligations, rights and privileges of the assignor to such parking space; in like manner and effect as if such assignee had been granted such privilege by the Developer.

Any unit owner shall have the right to lease any parking space which he has the exclusive privilege to use pursuant to any of the terms hereof to any other unit owner for such period, and upon such terms, as he sees fit.

At the time of the election of the first Board, the Developer shall furnish the Board with a list of all parking spaces, the use of which have been granted to unit owners as aforesaid, and the unit owners to whom the use of such spaces has been granted.

Each unit owner who is granted the exclusive privilege to use a portion of the enclosed parking area (or his assignee, if such privilege is assigned as hereinafter provided) shall pay the Board, or as it may direct, the sum of Five Dollars (\$5.00) each month for each enclosed parking space as part of the total monthly assessment.

Each owner who has been granted the right to the exclusive use of an outdoor space shall pay a fee of Two Dollars (\$2.00) per month as part of the total monthly assessment.

To the extent the Board increases the monthly assessment fees, the percent of increase shall be applied to the total monthly assessment which shall include this parking fee. Said sum when paid shall become part of the maintenance fund. Any monthly payment or portion thereof, if not paid when due and until so paid by the respective unit owner, shall constitute a lien on the interest of such unit owner in the property, which lien may be perfected and foreclosed in the manner provided in Section 9 of the Illinois Condominium Property Act with respect to liens for failure to pay a share of the common expenses.

Any unit owner shall have the right to lease any parking space which he has the exclusive privilege to use pursuant to any of the terms hereof to any other unit owner for such period ar d upon such terms as he sees fit, upon delivery of a copy of such assignment ar d consent to the Board.

Except to the extent expressly set forth hereinal ove, the remaining provisions of the Declaration shall continue in effect without change.


