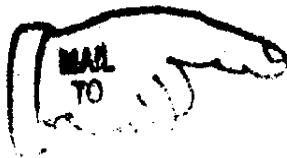
SUBCONTRACTOR'S RELEASE OF CLAIM ON PUBLIC FUNDS
