Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. - D. RENT LOSS INSURANCE. Borrower shall maintain insurance against rent loss in addition to the other hazards for which insurance is required by Section 5.
 - E. "BORROWER'S RIGHT TO REINSTATE" DELETED. Section 19 is deleted.
- F. BORROWER'S OCCUPANCY. Unless Lender and Borrower otherwise agree in writing, Section 6 concerning Borrower's occupancy of the Property is deleted.

This assignment of Rents constitutes an absolute assignment and not an assignment for additional security only.
