## SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR PROVIDENCE OF PALATINE CONDOMINIUM ASSOCIATION

This Second Amendment to the Declaration of Condominium Ownership And Of Easements, Restrictions, Covenan's and By-Laws For Providence Of Palatine Condominium Association dated March 23, 2006, and recorded with the Cook County Recorder of Deeds on March 27, 2006 as Document Number 0608631064, as amended from time to time (said Declaration and any amendments hereto are hereinafter referred to as the "Declaration"), is executed by Humnie! WHEREAS, the Declarant, pursuant to Article 14 of the Declaration, desires to annex and add the real estate describe on Exhibit "A-1" attached hereto ("Additional Parcel"), to the property and add to the plan of condominium ownership, and submit the Additional Parcel to the Act;

WHEREAS, the Additional Parcel is a portion of the Future Expansion Parcel in the Declaration as described in the Exhibit "D" therein;

WHEREAS, the Declarant desires to amend the Declaration as it relates to the Plat of Survey (Exhibit "C" thereto) and to the percentage of ownership interest in the common elements for condominium units (Exhibit "B" thereto); and

WHEREAS, under Article 14 of the Declaration, a power coupled with an interest is granted to the Declarant acting by and through its duly authorized officers as attorney-in-fact to shift the percentage ownership in the common elements appurtenant to each Unit to the percentages set forth in the Amendment to Declaration;

- 2. Exhibit "C" of the Declaration, "Plat of Survey", is hereby amended by adding the Additional Parcel Flat of Survey attached hereto as Exhibit "C".
- 3. Exhibit "B" of the Declaration, "Percentage of Ownership Interest in the Common Elements", is deleted and an amended Exhibit "B" is attached hereto is substituted therefore.
- 4. All the unit owners and mortgage polders by the Declarant, hereby consent to this Amendment to the Declaration pursuant to the powers set forth in Article 14 of the Declaration.
- 5. Except as herein specifically amended, the Ceclaration is ratified and confirmed. In the event of any inconsistency between this Amendment and the Declaration, this Amendment shall control.
