WHEREAS, The Grantor is justly indebted upon a principal Installment Note (NOTE AND CLOSED-END DISCLOSURE STATEMENT AND CREDIT AGREEMENT) bearing even date herewith, payable to NILES TOWNSHIP SCHOOLS CREDIT UNION in the principal amount of \$70,000.00, payable in 59 monthly installments of \$356.00 plus one final installment of \$69,955.23, which represents reduction of the principal balance plus interest thereon at the rate of 6.000% per annum, as per the tenor of the said Note.
