MODIFICATION OF REVOLVING CREDIT LOAN AGREEMENT AND MORTGAGE

This Modification of Revolving Credit Loan Agreement and Mortgage (the "Modification") is made this 17th day of March 2006 by and between JAMES F. MARRAN T/U AND BARBARA H. MARRAN T/U THE JAMES F. A. By that certain Mortgage (the "Mortgage", Lated March 7, 2002 by and between Borrower and Lender, as Mortgagee, recorded on March 27, 2002. as Document No. 0020345817, modified and recorded June 24, 2004 as Document # 0417611262 with the Recorder of Deeds of Cook County, Illinois, the Borrower mortgaged to Lender that certain real property located in Cook County, Illinois, legally described as follows:

The Mortgage secures the Revolving Credit Loan Agreement (the "Agreement") of even date establishing a line of credit in the amount of \$325,000.00, with a term of 60 months, the maturity date of which is March 1, 2007.

- B. Borrower wishes to increase the total amount of indebtedness allowed under the line of credit and the amount secured by the said Modification to \$375,000.00, and Lender agrees to this modification with respect to the line of credit limit and mortgage amount.
- C. Borrower wishes to extend the term of the Agreement to March 1, 2011.
- D. The Disclosure Statement and Mortgage are hereby modified and amended as follows:
 - 1. The grant set forth in the Mortgage is made for the purpose of securing, and shall secure payment of the Agreement with interest thereon, according to its terms, per the credit limit of \$375,000.00, as well as payment by Borrower of all sums due and owing under and performance of all obligations set forth in the Agreement and this Modification, and satisfaction and performance by Porrower of each and every obligation of Borrower set forth in the Agreement, Mortgage or this Modification.
 - 2. The credit limit as set forth in the Disclesure Statement is increased to \$375,000.00.
 - 3. The last full sentence in Covenant 23 (Future Advances) of the Mortgage is hereby amended to read: "However, no advances will be mad, beyond February, 2011."
 - 4. The Agreement is hereby modified as follows:
 - a. The section titled PRINCIPAL REDUCTION shall read "During the draw period the minimum payment may not fully repay the principal that is outstanding on your line, depending on when you take your draws, even though the term of this loan is 180 months and the amortization is based on a 180 month payback."
 - b. The Maturity Date is amended to read **March 1, 2011.**Page 2 of 4
