Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. Lender may require Borrower to pay, in connection with this Loan, either: (a) a one-time charge for flood zone determination, certification and tracking services; or (b) a one-time charge for flood zone determination and certification services and subsequent charges each time remappings or similar changes occur which reasonably might affect such determination or certification. shall continue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. (C) Payment Change Dates

My monthly payment may change as required by Section 3(D) below beginning on the 1st day of June, 2007, and on that day every 12th month thereafter.
