THIS INDENTURE WITNESSETH, That the Grantor/s, Dolores Kustom, single of 16720 Cardinal Drive, Orland Park, IL 60462 and in consideration of Ten -----\$10.00)----- Dollars, and other good and valuable considerations in hand, paid, Convey(s) and Warrant(s) unto the **PALOS BANK AND TRUST COMPANY**, an Illinois Banking Corporation of the United States of America, as Trustee under the provisions of a Trust Agreement dated the 9th day of May, 2006 and known as Trust Number 1-6856 the following described real estate in the County of Cook and the State of Illinois, to wit:

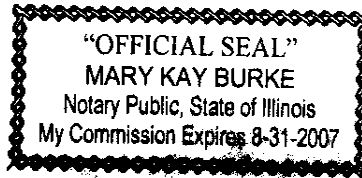

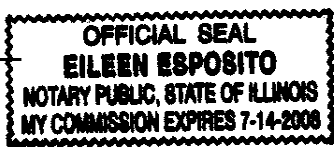
