UNIT NO. 40C IN THE 1000 LAKE SHORE PLAZA CONDOMINIUM, AS DELINEATED ON A SURVEY ATTACHED AS EXHIBIT "A" TO DECLARATION OF CONDOMINIUM MADE BY AMALGAMATED TRUST AND SAVINGS BANK, AS TRUSTEES, UNDER TRUST AGREEMENT DATED AUGUST 18, 1976 AND KNOWN AS TRUST NO. 3067, RECORDED IN THE OFFICE OF THE RECORDER OF COOK COUNTY, ILLINOIS, AS DOCUMENT NUMBER 23675015; TOGETHER WITH ITS UNDIVIDED PERCENTAGE INTEREST ON THE PROPERTY DESCRIBED IN SAID DECLARATION OF CONDOMINIUM AFORESAID (EXCEPTING THE UNITS AS DEFINED AND SET FORTH IN THE DECLARATION AND SURVEY), TOGETHER WITH THE TENAMENTS AND APPURTENANCES THEREUNTO BELONGING, IN COOK COUNTY, ILLINOIS.

The above described property is more commonly known as 1000 Lake Shore Plaza Unit #40C, Chicago, Illinois, and has permanent index number 17-03-204-064-1106 is hereinafter referred to as the "Property." Contractor was Owner's general contractor for the improvement of the Property.

On information and belief, prior to December 20, 2005, Owner, or someone authorized or knowingly permitted by the Owner to do so, entered into a contract with Contractor wherein Contractor was to provide labor, materials and equipment for the construction of repairs, alterations and improvements to and for the benefit of the Property.

On December 20, 2005, Contractor entered into a contract with International to furnish and install labor, materials, equipment and supplies necessary to install certain marble and

granite materials under the Contractor's contract with Owner, or one knowingly permitted by the Owner to contract for construction on the Property. On April 13, 2006 International fully and satisfactorily completed all work under its contract with Contractor. Pursuant to the contract with Contractor, Contractor was obligated to pay International \$21,194.42, including all change orders, required to be performed by International.

Contractor is entitled to credits in the amount of \$0.00, leaving due, unpaid and owing to International, after allowing for all credits, the sum of \$21,194.42, for which, with interest and attorney's fees International claims as a lien on the Property and all improvements thereon and on the money, bonds, warrants and other considerations due or to become due from the Owner and Contractor, under said contract between Contractor and Owner. All of the labor, materials, equipment and work performed by International were performed and furnished with the knowledge and consent of the Owner, and Owner knowingly permitted Contractor to enter into contracts for the improvement of the Property, including the contract between International and Contractor's prime contract with Owner and Contractor's subcontract with Contractor. International were for the improvement of the Property.

Notice has been duly given to Owner, and persons otherwise interested in the above described real estate, as to the status of the undersigned as subcontractor as provided by the Illinois Mechanics Lien Act 770 ILCS 69/5 and 60/24 (1992).
