### ORDINANCE NO. 0-91-38

## AN ORDINANCE GRANTING A ZONING VARIATION (13 WATERGATE ROAD - LOT 114 IN COVES UNIT 4)

WHEREAS, a petition for a variation from the provisions of the Zoning Ordinance of the Village of South Barrington (the "Village") has been filed by the owner of the property described on Exhibit A attached hereto and made a part hereof (the "Subject Property"); and,

WHEREAS, a portion of a previously constructed swimming pool deck, fence and landscaping planter extends approximately eleven (11) feet over the side yard setback line on the sorth side of the Subject Property; and,

WHEREAS, the question of granting the variation as described in Section 2 of this Ordinanc and section 2 of the Village; and,

WHERE is the said Zoning Board of Appeals held a public hearing on the question as required by law, due notice having been given of said hearing; and,

WHEREAS, the said Zoning Board of Appeals made findings in accordance with the statutes made and provided and has accommended the granting of the variation described in Section 2 of this Ordinance subject to the terms and conditions set forth in Section 3 of this Ordinance;

NOW, THEREFORE, BE IT ORDADIED by the President and Board of Trustees of the Village of South Barrington, Cook County, Illinos as follows:

Section 1. The President and Board of Trustees hereby find that the facts and statements contained in the preamble to this Ordinance are true and correct and hereby adopt the same as part of this Ordinance.

Section 2. A variation is hereby granted from the terms of the Zoring Ordinance of the Village of South Barrington applicable to the Subject Property to permit the above described eleven (11) foot encroachment over the side yard setback line on the north side of the Subject Property.

Section 3. The variation described in Section 2 hereof is conditioned upon the toll giving requirements:

- a. The variation shall apply only to those improvements which are in existence as of the date of passage of this Ordinance.
- b. In the event of future construction work on the pool, pool deck or fence, apart from normal and proper maintenance thereof, the encroaching improvement will at the time of such construction be brought into compliance with the Zoning Ordinance of the Village.
