MODIFICATION OF MORTGAGE

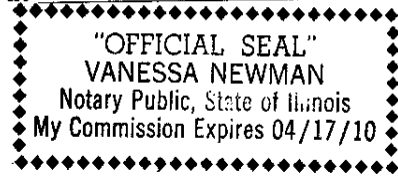

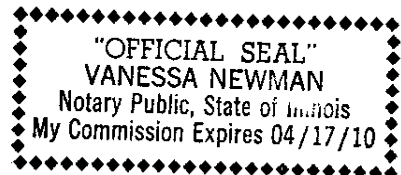
