



## 4. GENERAL PROVISIONS

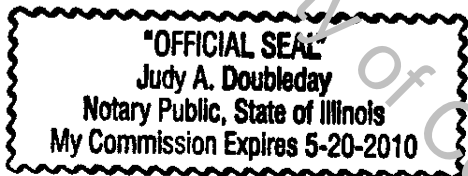
