MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated April 5, 2006, is made and executed between Chicago Title Land Trust Company Successor Trustee to Fifth Third Bank, Successor Trustee to Old Kent Bank, Successor Trustee to Pinnacle Bank, Successor Trustee to First National Bank of Cicero as Trustee U/T/A dated July 17, 1980 and known as Trust No. 6783, not personally but as Trustee on behalf of Trust Number 6783, whose address is 6316 North Northwest Highway, Chicago, IL 60631 (referred to below as "Grantor") and First Bank, whose address is 2100 South Elmhurst Road, Mount Prospect, IL 60056 (referred to below as "Lender").

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

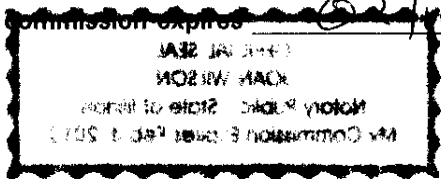
