

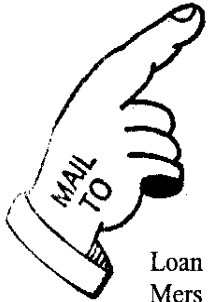

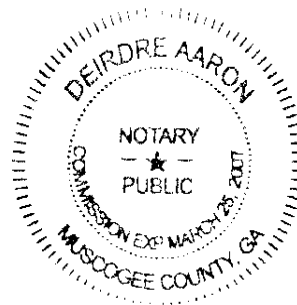

LEGAL DESCRIPTION - EXHIBIT A

Legal Description: Lot 2-D in Weatherstone of Inverness, being described as:

That part of Lot 2, in Weatherstone of Inverness, being a subdivision of that part of the South half of the Southwest quarter of Section 12, Township 42 North, Range 9 East of the Third Principal Meridian lying East of the Centerline of Barrington Road and West of a line running North from a point in the South line of said Section 528.0 feet West of the Southeast corner of said Southwest quarter to a point in the North line of the South half of the Southwest quarter of said Section 526.50 feet West of the North and South quarter section line of said Section 12, in Cook County, Illinois.
