On a date unknown to Lien Claimant, Owner or one knowingly permitted by the Owner to do so, entered into a contract with Contractor wherein Contractor was to provide labor, materials and equipment for the construction of the Salvation Army Red Shield Center and improvements to and for the benefit of the premises.
- 3. On or about July 12, 2005, Contractor made a subcontract with Lien Claimant to provide precast concrete services, including labor, materials, fixtures and equipment to the premises in the amount of Five Hundred Sixty-Two Thousand Dollars and 00/100 (\$562,000.00) for said improvement.
- On April 19, 2006, Lien Claimant substantially completed all required by said contract and extras to be done to the value of \$562,000.00.
- 5. Contractor is entitled to credits on account thereof as follows: \$473,407.00, leaving due, unpaid and owing to Lien Claimant, after allowing all credits, the sum of \$88,592.00 for which, with interest, Lien Claimant claims a lien on the premises and improvements and to monies or other considerations due or to become due from Owner under said contract between Contractor and Owner.
- 6. Notice has been d'ily given to Owner and the Contractor as required by the Illinois Mechanics Lien Act, //0 ILCS 60/24 (West, 2002). On information and belief notice has also been given to the Owner and others pursuant to 7/0 ILCS 60/5 (West, 2002).
