Grantor also hereby releases and waives all rights under and by virtue of the Homestead Exemption Laws of the State of Illinois.

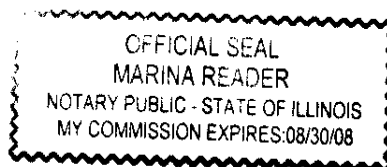

4. The provisions of the Declaration of Covenants, Conditions, Restrictions and Reciprocal Easements for 3058 North Lincoln recorded as Document No. 0607444118 including all amendments thereto.
5. Applicable zoning and building laws and ordinances and other ordinances of record.
6. Encroachments, if any.
7. Acts done or suffered by Grantee or anyone claiming by, through or under Grantee.
8. Leases and licenses affecting the Common Elements as defined in the Condominium Declaration.
9. Covenants, conditions, agreements, building lines and restrictions of record.
10. Easements recorded at any time prior to Closing, including any easements established by or implied from the Condominium Declaration or amendments thereto.
11. Liens, encroachments and other matters over which the Greater Illinois Title Company is willing to insure over at Grantor's expense; provided, however, that the title exceptions described in 6, 7, 8, or 10 above shall not prohibit the Grantee's use of the Unit as a single-family residence.
