Thompson, d/b/a El Coqui and Earnest Thompson for personal injuries on February 13, 2000 arising out of a dram shop action. A copy of the retainer agreement is attached hereto.

That on January 5, 2001, suit was filed a ainst Sharla G. Thompson d/b/a El Coqui and Earnest Thompson in the Circuit Court of Cook County, Illinois, County Department, Law Division and assigned as cause number 01 L 162 and subsequently assigned docket number 03 L 15409.

That on November 18, 2004, a judgment was entered in said court in favor of the plaintiff, Leonel Rea a/k/a Marcelino Rea and against the defendants Sharla (j. Thompson d/b/a El Coqui and Earnest Thompson in the amount of \$350,000.00.

That on November 30, 2004 a Memorandum of said judgment was recorded with the Recorder of Deeds of Cook County, Illinois as document number 0433527082.


