#### WITNESSETH:

WHEREAS, the real estate described on Exhibit A hereto and commonly known as 1101 Grove Street, Evanston, Il inois, was submitted to the Condominium Property Act of the State of Illinois (the "Act") pursuant to a Declaration of Condominium Ownership recorded in the office of the Recorder of Deeds of Cook County, Illinois on May 3, 1982 as Document Number 26218431 (the "Declaration");

WHEREAS, Stephen Martin (the "Unit (A) Owner") is the record owner of Unit 4A in The Plymouth Condominium Association (the "Association").
