NOW COMES affiant, Robert Duffing, being first duly sworn, who deposes and says:

- 1. I am a citizen of the United States and am over the age of eighteen.
- 2. I am the president of Northern Illinois Realty, Inc., an Illinois corporation ("NIR").
- 3. NIR owns 150% membership interest in 401 W. Winnecona, LLC, an Illinois limited liability company (the "Company"). Emerald Construction Group, LLC, an Illinois limited liability company ("Emerald") owns a 25% interest in the Company.
- 4. On August 16, 2004, NIR conveyed title to the real property described on Exhibit A attached hereto (the "Real Property") to the Company. A copy of the Warranty Deed conveying title is attached hereto as Exhibit B.
- 5. Pursuant to the Amended and Restated Operating Agreement of the Company (the "Operating Agreement"), only a Manager of the Company has the authority to sell assets of the Company or otherwise act on behalf of the Company.
- 6. Since January of 2006, Jon O'Connor has purported to be one of the Managers of the Company.
- 7. On June 26, 2006, and in accordance with the applicable provisions of the Company's Operating Agreement, NIR and Emerald, who own 75% of the membership interests of the Company voted to remove Jon O'Connor as Manager of the Company. A copy of the Written Consent evidencing Mr. O'Connor's removal as a Manager of the


