
NOTICE OF LIEN

property.





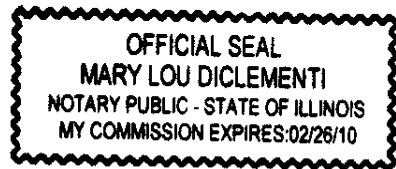
