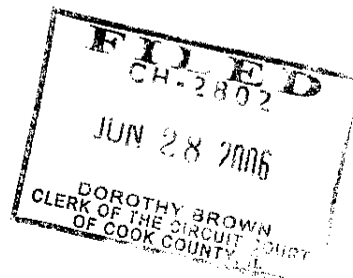

2. The Mortgage recorded as document number, 0432946023, with the COOK County Recorder on 11/24/04 is reformed to reflect that the property legally described as:

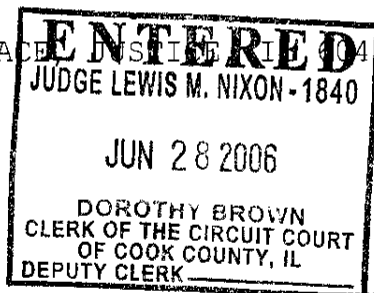
