UNIFO'M COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payme it of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Borrower shall pay when one the principal of, and interest on, the debt evidenced by the Note and any prepayment charges and late charges due under an hote. Borrower shall also pay funds for Escrow Items pursuant to Section 3. Payments due under the Note and this Security Instrument shall be made in U.S. currency. However, if any check or other instrument received by Lender as payn ent under the Note or this Security Instrument is returned to Lender unpaid, Lender may require that any or a 1 subsequent payments due under the Note and this Security Instrument be made in one or more of the following forms, as elected by Lender: (a) cash; (b) money order; (c) certified check, bank check, treasurer's check or cashier's cleet, provided any such check is drawn upon an institution whose deposits are insured by a federal agency, instrumentalit, or on thy; or (d) Electronic Funds Transfer.

5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. If Borrower fails to maintain any of the coverages described above, Lender may obtain insurance coverage, at Lender's option and Borrower' exp use. Lender is under no obligation to purchase any particular type or amount of coverage. Therefore, such coverage shall cover Lender, but might not protect Borrower, Borrower's equity in the Property, or the contents of the Property, against any risk, hazard or liability and might provide greater or lesser coverage than was previous. 6. Occupancy. Borrower shall occupy, establish, and use the Property as Borrower's principal residence within 60 days after the execution of this Security Instrument and shall continue to occupy the Property as Borrower's principal residence for at least one year after the date of occupancy, unless Lender otherwise agrees in writing, which consent shall not be unreasonably withheld, or unless extenuating circumstances exist which are beyond Borrower's control.

7. Preservation, Maintenance and Protection of the Property; Inspections. Borrower shall not destroy, damage or impair the Property, allow the Property to deteriorate or commit waste on the Property. If (a) Borrower fails to perform the covenants and agreements contents in the Property and/or rights under this Security Instrument, (b) there is a legal proceeding that might significantly affect Lender's interest in the Property and/or rights under this Security Instrument (such as a proceeding in bankruptcy, probate, for condernation or forfeiture, for enforcement of a lien which may attain priority over this Security Instrument or to enforce it as or regulations), or (c) Borrower has abandoned the Property, then Lender may do and pay for whatever is reasonable on appropriate to protect Lender's interest in the Property and rights under this Security Instrument, including potential, and/or assessing the value of the Property, and securing and/or repairing the Property. Lender's actions can include, but are not limited to: (a) paying reasonable attorneys' fees to protect its interest in the Property and/or rights under his Security Instrument, including its secured position in a bankruptcy proceeding.
