- 3. <u>Binding Effect</u>. This Release shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
 - 4. Governing Law. This Release shall be governed by the laws of the State of Illinois.
- 5. <u>Capitalized Terms</u>. Capitalized terms not otherwise defined herein shall have the same meaning as set forth in the Declaration.
