- 2. The amount remaining unpaid on the indebtedness is ONE HUNDRED EIGHTY FIVE THOUSAND FOUR HUNDRED SEVENTY FOUR EIGHT CENTS UNITED STATES DOLLARS (\$185,474.08).
- 3. Said indebtedness of \$200,000.00 shall be paid on or before June 15, 2007 as provided in the Revolving Credit Note, or notes, copies of which is attached hereto as Exhibit A.

"Prime Rate" shall mean at any time the rate per year announced by the WALL STREET JOURNAL called the prime rate, which may not at any time be the lowest rate charged by the Lender; and the applicable interest rate under this Note shall change on the date set forth in each announcement.
