 - 7. That COMPTEX is entitled to credits for payments in the amount of \$1,145.35.
- 8. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by COMPTEX the balance of Forty-Five Thousand. Five-Hundred and Four Dollars & 19/100, (\$45,504.19), for which with interest, Claimant claims a lien on the Real Estate and on the monies or other considerations due, or to become due from Owner(s) to Comptex Development, Inc.
