Capitalized terms not otherwise defined herein shall have the meaning set forth in that certain Declaration of Restrictive Covenants (as amended, the "Declaration") for Jazz on the Boulevard, dated as of August 1, 2004 and recorded in the Recorder's Office of Cook County on August 12, 2004 as Document No. 0422501208, as amended by First Amendment thereto dated August 1, 2005 and recorded in the Recorder's Office of Cook County on November 21, 2005 as Document No. 0532527119, by Second Amendment thereto dated November 22, 2005 recorded in the Recorder's Office of Cook County on November 27, 2005 as Document No. 0532741157, and by Third Amendment thereto dated December 7, 2005 recorded in the Recorder's Office of Cook County on December 12, 2005 as Document No. 0534645127 and by Fourth Amendment thereto dated March 29, 2006 recorded in the Recorder's Office of Cook County on March 30, 2006 as Document No. 0608927083.

WITNESSETH

WHEREAS, the Authority, Jazz and the Partnership have previously executed and recorded the Declaration, which encumbers certain property described in Experts A and B thereto with certain affordability requirements, and imposes certain other obligations upon the Partnership; and

WHEREAS, Jazz has converted to a condominium form of ownership or is simultaneously with the recording of this Amendment converting to a condominium form of ownership, the Rental Units and For Sale Units identified as such on Exhibits 1 (the "Converted Rental Units") and 2 to this Amendment, respectively, together with their undivided interest in all common elements and limited common elements and appurtenants rights; and

WHEREAS, Jazz is concurrently herewith conveying the Converted Rental Units to the Partnership; and

SECTION 1. AMENDMENT OF EXHIBIT B. Exhibit B to the Declaration is hereby amended and restated to read as set forth in Exhibit 3 of this Amendment to the Declaration.

SECTION 2. FULL FORCE AND EFFECT. Except as amended by this Amendment to the Declaration, the terms of the Declaration remain in full force and effect, and are incorporated herein by reference as though fully set forth herein.

SECTION 3. COUNTERPARTS. This Amendment to the Declaration may be executed in multiple counterparts, each of which shall be an original, but all of which shall constituent but one and the same agreement.
