**RELEASE OF MORTGAGE**

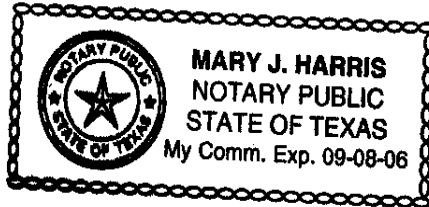
