MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated July 10, 2006 is made and executed between Oakley G. Stevens, Sr. and Pamela T. 

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.



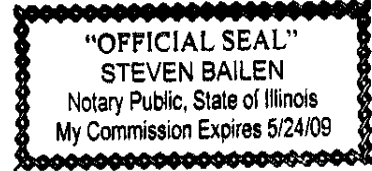
