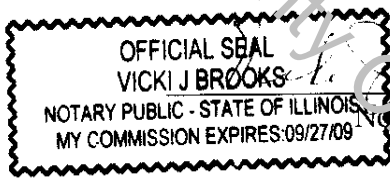

LEGAL DESCRIPTION FOR PARAMOUNT LOFT CONDOMINIUMS
