**MODIFICATION.** Lender and Grantor hereby modify the Mortgage as follows:

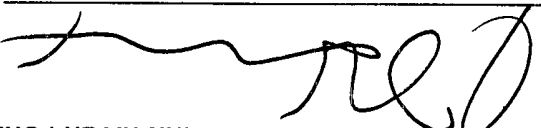
The Principal Balance is being increased from \$450,000.00 to \$500,000.00.

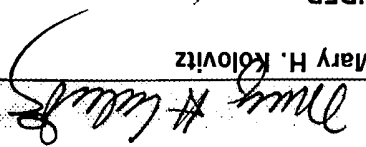

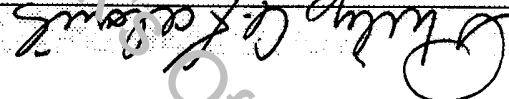
