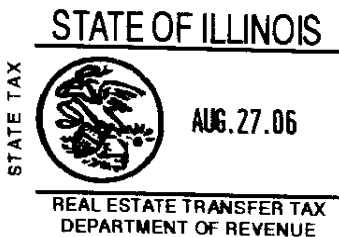
SPECIAL WARRANTY DEED

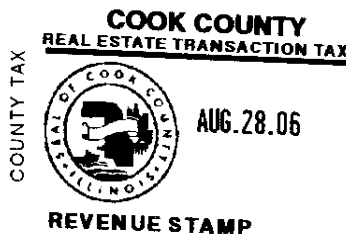
