Grantor further reserves to itself and its successors and assigns, and Grantee hereby grants to Grantor and its successors and assigns, the right to remedy as provided in the Purchase Agreement dated July 5,2006 between 918 West Ainslie, LLC, an Illinois limited liability company and Daniel Odroniec for the purchase of the real estate (the "Purchase Agreement") the terms of which are set forth in Exhibit A, attached hereto and made a part hereof. The foregoing right of remedy herein reserved by Grantor and granted by Grantee pursuant to the Purchase Agreement is hereby subordinated to the rights of the holder of any mortgage or trust deed hereafter placed upon the real estate described therein.
