This land and all improvements upon it are referred to as "the premises." The Owners continue to own the premises to date.

On or before March 17, 2005, Owners entered into a contract with Greif Properties, Inc., for Greif Properties, Inc., to provide general contracting services, for the construction of a condominium building upon the premises.

On or about March 17, 2005, Greif Properties, Inc., with the knowledge and/or approval and/or consent of the Owners, entered into a written contract with Claimant, for the Claimant to furnish and/or install electrical related work and materials and services on and for the premises, including but not limited to temporary power and lighting, installation of all new lighting and lamps, installation of exit and emergency lighting systems, new power devices, telephone outlets, underground utility service conduits, fire alarm system, power feed and hood up for HVAC equipment, main electrical service, fire pump and jockey pump feeds, elevator power, electronic door intercom and entry system, value engineering of power distribution system, for \$841,000.00. In the alternative, Greif Properties, Inc., was Owners' agent with authority to contract for the Owners for improvements to the Premises, and on March 17, 2005, Greif Properties, Inc., entered into the written subcontract with Claimant, for Claimant to provide these materials and labor and services for this amount, with the knowledge and/or approval and/or consent of the Owners. Greif Properties, Inc., with the knowledge, consent and/or approval of the Owners, ordered the Claimant to furnish extra materials and labor (including vault change order, revised; second floor upgrades; and third floor upgrades) of the value of \$20,991.00 making Claimant's total contract amount the sum of \$861,991.00. The Owners (and/or Owners' Agent, with the consent, knowledge and/or approval of the Owners), accepted the contract for improvements.

On June 14, 2006, Greif Properties, Inc., wrongfully terminated the contract and prevented Claimant from completing same. Claimant last provided labor and materials on this date, June 14, 2006. At this time of wrongful termination, Claimant completed the following amount: \$726,741.45; Claimant provided labor and materials to the value of \$726,741.45. The reasonable value of the materials, labor, and services Claimant provided is at least this amount.

Greif Properties, Inc. and/or Owners are entitled to credits on account thereof as follows: \$588,450.00 in payments made to Claimant. Leaving due unpaid and owing to the Claimant the balance of \$138,291.45, for which, with interest, Claimant claims a lien on the Premises and monies or other considerations due or to become due from the Owners and Greif Properties, Inc.

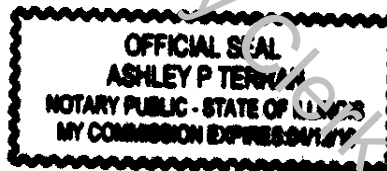


