In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

If the Property is abandoned by Borrower, or if Borrower fails to respond to Lender within 30 days from the date notice is mailed by Lender to Borrower that the insurance carrier offers to settle a claim for insurance benefits, Lender is authorized to collect and apply the insurance proceeds at Lender's option either to restoration or repair of the Property or to the sums secured by this Mortgage.

- 14. Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and of this Mortgage at the time of execution or after recordation hereof.
- 15. Rehabilitation Loan Agreement. Borrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, repair, or other loan agreement which Borrower enters into with Lender. The receiver shall be liable to account only for those rents actually received.

- **C. Public Liability Insurance.** Borrower shall take such actions as may be reasonable to insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount, and extent of coverage to Lender.
- **D. - F. Remedies. If Borrower does not pay condominium dues and assessments when due, then Lender may pay them. Any arrounts disbursed by Lender under this paragraph F shall become additional debt of Borrower secu ed by the Security Instrument. Unless Borrower and Lender agree to other terms of payment, these arrounts shall bear interest from the date of disbursement at the Note rate and shall be payable, with irrelest, upon notice from Lender to Borrower requesting payment.
