- (ii) Security Agreement (Borrower Bonds) dated as of July 1, 2001, by and among the Mortgagor, LaSalle Bank National Association, as national banking association, as Trustee, and the Bank;
- (iii) Mortgage and Security Agreement dated as of July 1, 2001 (the "Mortgage"), from the Mortgagor to the Bank, recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on July 18, 2001, as Document No. 0010639419;

WHEREAS, the Cocuments, as modified and amended by the Previous Modification, encumber the real es'ate described in Exhibit A attached hereto and the personal property located thereon; and

WHEREAS, the parties desire to make certain modifications and amendments to the Documents, as modified and amended by the P evious Modification, as more fully provided for herein;

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements contained herein, and other good and variable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- Section 1. Recitals Part of Agreement; Capitalized Terms. (a) The foregoing recitals are hereby incorporated into and made a part of this Agreement.
- (b) All capitalized terms used and not otherwise defined herein shall have the meanings specified in the Reimbursement Agreement.
- (c) Except as otherwise stated herein, all references in this Agreemer's p any one or more of the Documents shall be deemed to include the previous modifications and amendments to the Documents provided for in the Previous Modification, whether or not express reference is made to such previous modifications and amendments.
- Section 2. Extension of Stated Expiration Date. The Bank hereby agrees to issue an amendment to the Letter of Credit extending the Stated Expiration Date of the Letter of Credit from July 15, 2006, to October 15, 2006. All references in the Documents to the Stated Expiration Date of the Letter of Credit shall henceforth be to the date October 15, 2006, and all of the Documents are hereby modified and amended accordingly. Without limitation on the generality of the foregoing provisions of this Section, the date "July 15, 2006" in Section 2.1 of the Mortgage is hereby changed to "October 15, 2006."

Section 3. Representations and Warranties. In order to induce the Bank to enter into this Agreement, the Mortgagor hereby represents and warrants to the Bank as follows as of

the date of this Agreement and if different, as of the date of the execution and delivery of this Agreement:

- (a) The Mortgagor is a not for profit corporation duly organized, validly existing and in good standing under the laws of the State of Illinois, has all necessary power and authority to carry on its present business, and has full right, power and authority to enter into this Agreement, the Documents and the Previous Modification and to perform and consummate the transactions contemplated hereby and thereby.
- (b) This Agreement, the Documents and the Previous Modification have been duly authorized, executed and delivered by the Mortgagor constitute a valid and legally binding obligations enforceable against the Mortgagor. The execution and delivery of this Agreement, the Documents ard the Previous Modification and compliance with the provisions thereof under the circumstances contemplated therein do not and will not conflict with or constitute a breach or violation of or defaul under the articles of incorporation or bylaws of the Mortgagor, or any agreement or other instrument to which the Mortgagor is a party, or by which its is bound, or to which any of its properties are subject, or any existing law, administrative regulation, court order or consent decree to which it is subject.
- (c) The Mortgagor is in full compliance with all of the terms and conditions of the Documents and the Previous Modification, and no Default or Event of Default has occurred and is continuing with respect to any of the Discurrents or the Previous Modification.
- (d) There is no litigation or administrative proceeding pending or threatened to restrain or enjoin the transactions contemplated by this Agreement or any of the Documents or the Previous Modification, or questioning the validity thereof, or in any way contesting the existence or powers of the Mortgagor, or in which an unfavorable decision, ruling or finding would adversely affect the transactions contemplated by this Agreement or any of the Documents or the Previous Modification, or would result in any material adverse change in the financial condition, properties, business or operations of the Mortgagor.
- (e) The statements contained in the recitals to this Agreement are true and correct.

Section 4. Documents to Remain in Effect; Confirmation of Obligations; References. The Documents shall remain in full force and effect as originally executed and delivered by the parties, except as previously modified and amended by the Previous Modification and as expressly modified and amended herein. The Mortgagor hereby (i) confirms and reaffirms all of its obligations under the Documents, as previously modified and amended by the Previous Modification and as modified and amended herein; (ii) acknowledges and agrees that the Bank, by entering into this Agreement, does not waive any existing or future default or event of default under any of the Documents, or any rights or remedies under any of the Documents; (iii) acknowledges and agrees that the Bank has not heretofore waived any default or event of default under any of the Documents, or any rights or remedies under any of the Documents; and (iv) acknowledges that it does not have any defense, set off or counterclaim to the payment or performance of any of its obligations under the Documents, as previously modified and amended by the Previous Modification and as modified and amended herein. All references in the Documents to any one or more of the Documents, or to the "Account Party Agreements" or the "Bank Documents," shall be deemed to refer to such Document, Documents, Account Party Agreements or Bank Documents, as the case may be, as

previously modified and amended by the Previous Modification and as modified and amended by this Agreement.

Section 5. Certifications, Representations and Warranties. In order to induce the Bank to enter into this Agreement, the Mortgagor hereby certifies, represents and warrants to the Bank that all certifications, representations and warranties contained in the Documents and the Previous Modification and in all certificates heretofore delivered to the Bank are true and correct as of the date as of the date of this Agreement and if different, as of the date of the execution and delivery of this Agreement, and all such certifications, representations and warranties are hereby remade and made to speak as of the date of this Agreement and if different, as of the date of the execution and delivery of this Agreement.

Section 6. Entire Agreement; No Reliance. This Agreement sets forth all of the covenants, promises, agreements, conditions and understandings of the parties relating to the subject matter of this Agreement, and there are no covenants, promises, agreements, conditions or understandings, either oral or written, between them relating to the subject matter of this Agreement other than as are herein set forth. The Mortgagor acknowledges that it is executing this Agreement without relying on any statements, representations or warranties, either oral or written, that are not expressly set forth herein.

Section 7. Successors This Agreement shall inure to the benefit of and shall be binding upon the parties and their respective successors, assigns and legal representatives.

Section 8. Severability. In the event any provision of this Agreement shall be held invalid or unenforceable by any court of composion jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.

Section 9. Amendments, Changes and Modifications. This Agreement may be amended, changed, modified, altered or terminated only by a written instrument executed by all of the parties hereto.

Section 10. Construction. (a) The words "hereof," "herein" and "hereunder," and other words of a similar import refer to this Agreement as a whole and not to the individual Sections in which such terms are used.

- (b) References to Sections and other subdivisions of this Agreement as originally executed.
- (c) The headings of this Agreement are for convenience only and shall no define or limit the provisions hereof.
- (d) Where the context so requires, words used in singular shall include the plural and vice versa, and words of one gender shall include all other genders.
- (e) The Mortgagor and the Bank, and their respective legal counsel, have participated in the drafting of this Agreement, and accordingly the general rule of construction to the effect that any ambiguities in a contract are to be resolved against the party drafting the contract shall not be employed in the construction and interpretation of this Agreement.
