WHEREAS, on April 18, 2006 the Declarant caused to be recorded with the Cook County Recorder of Deeds, Amendment 1 to Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for 1924-28 West Diversey Condominiums as Document number 0610810080; and

WHEREAS, on April 21, 2006 the Declarant caused to be recorded with the Cook County Recorder of Deeds, Amendment 2 to Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (as theretofore amended) for 1924-28 West Diversey Condominiums as Document number 0611132048 (the "Declaration as heretofore amended"); and

WHEREAS, the Declaration as heretofore amended encumbers the Property legally described on Exhibit A attached hereto and made a part hereof (the "Property"); and

WHEREAS, the condominium project has not as yet been turned over to the Condominium Association; and

WHEREAS, it is the desire of Declarant to further amend the Declaration as heretofore amended to reflect that Limited Common Element, Roof Top North, which is indicated as a Limited Common Element with respect to Unit 3W shall be assigned to and is hereby assigned as a Limited Common Element with respect to Unit 1W; and

WHEREAS as heretofore amended the Declaration provided that the Owner of Unit 3W could sell, transfer, convey or grant rights of extended usage with respect to Roof Top North Limited Common Element to another Unit Owner in the 1924-28 West Diversey Condominiums; and

WHEREAS, the Owner of Unit 1W is a Unit Owner in the 1924-28 West Diversey Condominiums; and

WHEREAS, the Owners of Units 1E (Tom Konstantopoulos) and 3W (Nikolaos Theodosopoulos) desire to switch parking spaces and both have agreed thereto and the Declarant has also agreed to said exchange:

NOW, THEREFORE, the Declarant, for the purposes above set forth, declares as follows:

- 1. The Declaration as heretofore amended is here by further amended to assign, transfer, convey and set over the North Roof Top Limited Commor. Flement (as depicted on the Plat of Survey heretofore recorded with Amendment #2 as herein above indicated) as a Limited Common Element with respect to Unit 1W.
- 2. The Owners of Units 1E and 3W hereby both agree and the Declarant concurs that parking space P-4 will be a Limited Common Element with respect to Unit 1E and that parking space P-1 will be a Limited Common Element with respect to Unit 3W. This effects an exchange or switch of the indicated parking spaces affecting only Units 1E and 3W.

In all other respects, the Declaration shall remain unchanged and unaffected by this Amendment 3.
