2. Application of Payments or Proceeds. earthquakes and floods, from which Lender requires insurance, then: (i) Lender waives the provision in Section 3 for the Periodic Payment to Lender of the yearly premium installments for property insurance on the Property; and (ii) Borrower's obligation under Section 5 to maintain property insurar ce coverage on the Property is deemed satisfied to the extent that

the required coverage is provided by the Owners Association policy.

What Lender requires as 1cc ndition of this waiver can change during the term of the loan.

Borrower shall give Lender prompt notice of any lapse in required property insurance coverage provided by the master or blanket policy.
