MORTGAGE, ASSIGNMENT OF LEASES AND RENTS AND SECURITY AGREEMENT

This MORTGAGE, ASSIGNMENT OF LEASES AND RENTS AND SECURITY AGREEMENT (the "Mortgage") is made be ween Abel V. Bautista, (hereinafter referred to as "Mortgagor"), and AztecAmerica Bank, having ar office at 2136 S. Oak Park Avenue, Berwyn, IL 60402 (hereinafter referred to as "Mortgagee"). A Single Man.

WITNESS:

WHEREAS, Mortgagor is indebted to Mortgagee in the rru cipal amount of \$204,000.00 together with interest thereon from and after the date hereof at the rates provided in that certain Mortgage Note of even date herewith ("Mortgage Note"), which Mortgage Note provides for monthly payments of interest and principal with the entire then outstanding principal balance of the Mortgage Note with accrued interest thereon, if not sooner paid, due and payable by Mortgagor to Mortgagee on October 01, 2011; and

WHEREAS, as a condition of making the loan evidenced by the aforesaid Mortgage Note, Mortgagee has required that Mortgagor mortgage the "Premises" (as hereinafter defined) to the Mortgagee, and Mortgagor has executed, acknowledged, and delivered this Mortgage to secure any indebtedness existing at the date hereof and evidenced by the Mortgage Note and any modifications, renewals or extensions thereof, and any indebtedness represented by future advances from Mortgagee to Mortgagor, whether such advances are obligatory or to be made within twenty (20) years from the date hereof to the same extent as if such future advances were made on the date hereof, provided, however, that although the amount of indebtedness that may be secured by this Mortgage may increase from time to time, the total unpaid balance so secured at any one time shall not exceed a maximum principal amount of \$1,000,000.00, plus interest thereon, late charges and any disbursements made for the payment of taxes, special assessments,

insurance on the Premises, or other items deemed necessary by Mortgagee to be made to protect the lien thereof, together with interest at the Default Interest Rate herein specified on any such disbursements under the aforesaid Mortgage Note.

Mortgagor does, by these presents, grant, assign, convey, pledge, hypothecate, and mortgage unto Mortgagee, its successors and assigns forever, the Real Estate and all of its estates, rights, titles, and interests therein situated in the County of Cook, State of Illinois, legally described on Exhibit A attached hereto and made a part hereof (sometimes herein referred to as the "Real Estate"), which Real Estate, together with the following described property, is collectively referred to as the "Premises", together with:

- A. All right, title, and interest of Mortgagor, including any after-acquired title or reversion, in and to the beds of the ways, streets, avenues, and alleys adjoining the Premises;
- B. All and singular the tenements, hereditaments, easements, appurtenances, passages, liberties, and privileges thereof or in any way now or hereafter appertaining, including homestead and any other claim at law or in equity as well as any after-acquired title, franchise, or license, and the reversion and reversions and remainder and remainders thereof;
- C. All leases or other contracts of whatever nature or kind affecting the use, occupancy or ownership of the Premises, or any part thereof, now existing or which may be executed at any time in the future during the life of this Mortgage and all amendments, extensions, and renewals of said leases or other contracts of whatever nature or kind, and any of them, all of which are hereinafter called the "Leases" and all rents, profits, proceeds, issues, other income, and other payments of whatever nature or kind, which may now or hereafter be or become due or owing under the Leases and any of them or on account of the use, occupancy or ownership of any interest of or in the Premises, it being intended hereby to establish a collateral transfer of all Leases hereby assigned and all the rents, proceeds, profits, issues, other income, and other payments of whatever nature or kind arising thereunder or on account of the use, occupancy or ownership of any interest of or in the Premises (the "Rents Herein Assigned"); and
- D. All buildings and improvements of every kind and description now or hereafter erected or placed thereon and all materials intended for construction, reconstruction, alteration, and repairs of such improvements now or hereafter erected thereon, all of which materials shall be deemed to be included within the Premises immediately upon the delivery thereof to the Premises, and all fixtures, equipment, materials and other types of personal property (other than that belonging to tenants) used in the ownership and operation of the improvement situated thereon with parking and other related facilities, in possession of Mortgagor now or hereafter located in, on, or upon, or installed in or affixed to, the Real Estate legally described herein, or any improvements or structures thereon, together with all accessories and parts now attached to or used in connection with any such equipment, materials and personal property or which may hereafter, at any time, be placed in or added thereto, and also any and all replacements and proceeds of any such equipment, materials and personal property, together with the proceeds of any of the foregoing; it being mutually agreed, intended, and declared, that all the aforesaid property shall, so far as permitted by law, be deemed to form a part and parcel of the Real Estate and for the purpose of this Mortgage to be Real Estate, and covered by this Mortgage; and as to

any of the property aforesaid which does not so form a part and parcel of the Real Estate or does not constitute a "fixture" (as such term is defined in the Uniform Commercial Code in effect in the State of Illinois from time to time [the "Code"]), this Mortgage is hereby deemed to be, as well, a Security Agreement under the Code for the purpose of creating hereby a security interest in such property, which Mortgagor hereby grants to the Mortgagee as the Secured Party (as such term is defined in the Code), and Mortgagor hereby represents and warrants to Mortgagee that Mortgagor has and at all times hereafter shall have good and indefeasible title to the aforesaid property, free and clear of all liens, claims, security interests and encumbrances, including without limitation any claims of the members and managers of Mortgagor, except those of Mortgagee.

TO HAVE AND TO HOLD, the same unto the Mortgagee and its successors and assigns forever, for the purposes and uses herein set forth.

Provided, however, that if the Mortgagor shall pay the principal and all interest as provided by the Mortgage Note and any modifications, renewals or extensions thereof, and shall pay all other sums herein provided for, or secured hereby, and shall well and truly keep and perform all of the covenants herein contained, then this Mortgage shall be released at the cost of the Mortgagor, otherwise to remain in full force and effect.

- 1. MORTGAGOR'S COVENALTS To protect the security of this Mortgage, Mortgagor agrees and covenants with the Mortgagee that Mortgagor shall:
- A. <u>PAYMENT OF PRINCIPAL AND IN TEREST</u>. Pay promptly when due the principal and interest on the indebtedness evidenced by the Mortgage Note at the times and in the manner herein and in the Mortgage Note provided.
- B. TAXES AND DEPOSITS THEREFOR. (1) Pay inomediately when first due and owing, all general taxes, special taxes, special assessments, wat a charges, sewer charges, and other charges which may be levied against the Premises, and to purnish to Mortgagee upon request therefor, duplicate receipts therefor within thirty (30) days after payment thereof. Mortgagor may, in good faith and with reasonable diligence, contest the validity or amount of any such taxes or assessments provided: (a) that such contest shall have the effect of preventing the collection of the tax or assessment so contested and the sale or forfeiture of said Premises or any part thereof, or any interest therein, to satisfy the same; (b) that Mortgagor has notified Mortgagee in writing of the intention of Mortgagor to contest the same, before any tax or assessment has been increased by any interest, penalties, or costs; and (c) that Mortgagor shall have deposited with Mortgagee at such place as Mortgagee may from time to time in writing appoint, a sum of money, bond, Letter of Credit or other security acceptable to Mortgagee which shall be sufficient in the judgment of the Mortgagee to pay in full such contested tax and assessment and all penalties and interest that might become due thereon, and shall keep said money on deposit or keep in effect said bond or Letter of Credit in an amount sufficient, in the judgment of the Mortgagee, to pay in full such contested tax and assessment; and all penalties and interest that might become due thereon, and shall keep on deposit an amount so sufficient at all times, increasing such amount to cover additional penalties and interest whenever, in the judgment of the Mortgagee, such increase is advisable. In case the Mortgagor, after demand is

made upon it by Mortgagee, shall fail to prosecute such contest with reasonable diligence or shall fail to maintain sufficient funds on deposit as hereinabove provided, the Mortgagee may, at its option upon notice to Mortgagor, apply the monies and/or liquidate the securities deposited with Mortgagee, in payment of, or on account of, such taxes and assessments, or any portion thereof then unpaid, including the payment of all penalties and interest thereon. If the amount of the money and/or security so deposited shall be insufficient as aforesaid for the payment in full of such taxes and assessments, together with all penalties and interest thereon, the Mortgagor shall forthwith upon demand deposit with the Mortgagee a sum which, when added to the funds then on deposit, shall be sufficient to make such payment in full. Provided Mortgagor is not then in default hereunder, the Mortgagee shall, upon the final disposition of such contest and upon Mortgagor's delivery to Mortgagee of an official bill for such taxes, apply the money so deposited in full payment of such taxes and assessments or that part thereof then unpaid, together with all penalties and interest due thereon and return on demand the balance of said deposit, if any, to Mortgagor.

- (2) Mortgagee nay require that Mortgagor deposit each month, on the date when the monthly payment under the Mortgage Note is due with the Mortgagee, an amount equal to 1/12th of the annual general real estric taxes for the Premises, all as estimated by Mortgagee on a "when issued and payable" basis, with such additional reserve as may be required by Mortgagee. Mortgagee shall not be obligated to pay interest or earnings of any kind on funds on deposit with it pursuant to this Paragraph. Provided no Event of Default then exists, sums on deposit in such real estate tax reserve shall be made available to Mortgagor to pay real estate taxes due and payable.
- C. <u>INSURANCE</u>. (1) <u>Hazard</u>. Keep the improvements now existing or hereafter erected on the Premises insured under a replacement cost form of insurance policy against loss or damage resulting from fire, windstorm, and other hazards as may be required by Mortgagee, and to pay promptly, when due, any premiums on such insurance, provided however, Mortgagee may make such payments on behalf of Mortgagor. All insurance shall be in form and content as approved by the Mortgagee (which shall be carried in companies acceptable to Mortgagee) and the policies and renewals shall be currently paid and delivered to the Mortgagee at least thirty (30) days before the expiration of the old policies and shall have anached thereto standard noncontributing mortgage clause(s) in favor of and entitling Mortgagee to collect any and all of the proceeds payable under all such insurance, as well as standard waiver of subrogation endorsement, if available. Mortgagor shall not carry separate insurance, concurrent in kind or form and contributing in the event of loss, with any insurance required hereunder. In the event of any casualty loss, Mortgagor will give immediate notice by mail to the Mortgagee.
- (2) <u>Liability</u>, <u>Flood and Business Interruption Insurance</u>. Carry and maintain comprehensive public liability insurance, flood insurance and business interruption (or loss of rentals) insurance as may be required from time to time by the Mortgagee in forms, amounts, and with companies satisfactory to the Mortgagee. Such liability policy, flood insurance and business interruption insurance shall name Mortgagee as an additional insured party thereunder. Certificates of such insurance, premiums prepaid, shall be deposited with the Mortgagee and shall contain provision for thirty (30) days' notice to the Mortgagee prior to any cancellation thereof.

(3) Mortgagee may require that Mortgagor deposit each month, on the date when the monthly payment under the Mortgage Note is due with the Mortgagee, an amount equal to 1/12th of the annual insurance premiums for the insurance required by this Mortgage, as reasonably estimated by Mortgagee. Mortgagee shall not be obligated to pay interest or earnings of any kind on funds on deposit with it pursuant to this Paragraph. Provided no Event of Default then exists, sums on deposit in such insurance premium reserve shall be made available to Mortgagor to pay insurance premiums due and payable.

D. PRESERVATION AND RESTORATION OF PREMISES AND COMPLIANCE WITH GOVERNMENTAL REGULATIONS. Not permit any building or other improvement on the Premises to be materially altered, removed, or demolished, nor shall any fixtures or appliances on, ir, or about said buildings or improvements be severed, removed, sold, or mortgaged, without the prior written consent of Mortgagee, and in the event of the demolition or destruction in whole or in part of any of the fixtures, chattels, or articles of personal property covered hereby or by any separate security agreement given in conjunction herewith, the same shall be replaced promptly by similar fixtures, chattels, and articles of personal property at least equal in quality and condition to those replaced, free from any security interest in or encumbrances thereon or reservation of title thereto. Subject to the provisions of Paragraph 19 hereof, Mortgagor shall promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the Premises which may become damaged or be destroyed. The buildings and improvements shall be so restored or rebuilt so as to be of at least equal value and substantially the same character as prior to such damage or destruction.

Mortgagor further agrees to permit, cominity or suffer no waste, impairment, or deterioration of the Premises or any part or improvement thereof, ordinary wear and tear excepted; to keep and maintain the Premises and every part thereof in good repair and condition, subject to ordinary wear and tear, to effect such repairs as the Mortgagee may reasonably require, and, from time to time, to make all needful and proper replacements and additions thereto so that said buildings, fixtures, machinery, and appurtenances will, at all times, be in good condition, fit and proper for the respective purposes for which they were originally erected or installed; to comply with all statutes, orders, requirements or decrees relating to said Premises as provided in any notice given by any federal, state, or municipal authority; and to observe and comply with all conditions and requirements necessary to preserve and extend any and all rights, licenses, permits (including, but not limited to, zoning variances, special exceptions, and nonconforming uses) privileges, franchises, and concessions which are applicable to the Premises or which have been granted to or contracted for by Mortgagor in connection with any existing or presently contemplated use of the said Premises.

- E. <u>DUE ON SALE PROVISIONS CREATION OF LIENS</u>, <u>TRANSFER OF OWNERSHIP AND CHANGE OF MANAGEMENT</u>. (1) Not create, suffer, or permit to be created or filed against the Premises, any mortgage lien or other lien whether superior or inferior to the lien of this Mortgage; or
- (2) Not permit the Premises, in whole or in part, to be alienated, transferred, conveyed or assigned to any person or entity.

Any default in the performance or observance of any of the provisions of this Paragraph shall constitute an Event of Default as described in Paragraph 11 below and, thereafter, in addition to any other remedies hereunder, the entire indebtedness secured hereby, including, but not limited to, principal and accrued interest shall, at the option of the Mortgagee and without demand or notice to Mortgagor, become immediately due and payable with interest accruing thereafter on the unpaid principal balance of the Mortgage Note at the Default Interest Rate specified in the Mortgage Note and Mortgagee may proceed to foreclose this Mortgage.

Any waiver by Mortgagee of the provisions of this Paragraph shall not be deemed to be a waiver of the right of Mortgagee to insist upon strict compliance with the provisions of this Paragraph in the future.

F. ENVIRONMENTAL REPRESENTATIONS, WARRANTIES AND INDEMNITY.

- (1) Not use, generate, manufacture, produce, store, release, discharge, or dispose of on, under, or about the Premises, or transport to or from the Premises any Hazardous Substance (as defined herein) or allow any other person or entity to do so.
- (2) Keep and maintain the Pre nises in compliance with, and shall not cause or permit the premises to be in violation of any Environmental Laws (as defined herein) or allow any other person or entity to do so.
 - (3) Give prompt written notice to Mor gagee of:
 - (i) any proceeding or inquiry by a governmental authority whether federal, state, or local, with respect to the presence of any Hazardous Substance on the Premises or the migration thereof from or to other property;
 - (ii) all claims made or threatened by any third party against Mortgagor or any entity affiliated with it or the Premises relating to any loss or injury resulting from any Hazardous Substance; and
 - (iii) the discovery by Mortgagor of any occurrence or condition on any real property adjoining or in the vicinity of the Premises that could cause the Premises or any part thereof to be subject to any restriction on the ownership, occupancy, transferability or use of the Premises under any Environmental Laws.
- (4) Recognize Mortgagee's right to join and participate in, as a party if it so elects, any legal proceedings or actions initiated in connection with any Environmental Laws and Mortgagor hereby agrees to pay any attorneys' fees thereby incurred by the Mortgagee in connection therewith.
- (5) Indemnify, defend, and hold harmless Mortgagee, its directors, officers, employees, agents, contractors, attorneys, other representatives, successors and assigns from and against any and all loss, damage, cost, expense or liability, including by way of illustration and not limitation, attorneys' fees and court costs, directly or indirectly, arising out of or attributable to

the use, generation, manufacture, production, storage, release, threatened release, discharge, disposal, or presence of Hazardous Substance on, under, or about the Premises, including without limitation; (a) all foreseeable consequential damages; and (b) the costs of any required or necessary repair, cleanup, or detoxification of the premises, and the preparation and implementation of any closure, remedial or other required plans. This indemnity and covenant shall survive the reconveyance of the lien of this Mortgage, or the extinguishment of such lien by foreclosure or action in lieu thereof.

- (6) In the event that any investigation, site monitoring, containment, cleanup, removal, restoration or other remedial work of any kind or nature (the "Remedial Work") is reasonably necessary under any applicable local, state, or federal law or regulation, any judicial order, or by any governmental or nongovernmental entity or person because of, or in connection with, the current or future presence, suspected presence, release or suspected release of a Hazardous Substance in or into the air, soil, ground water, surface water or soil vapor at, on, about, under, or within the Premises, or any portion thereof, Mortgagor shall, within thirty (30) days after written demand for performance thereof by Mortgagee or governmental entity or agency (or such shorter period of time as may be required under any applicable law, regulation, order, or agreement), commence to perform, or cause to be commenced, and thereafter diligently prosecuted to completion, all such Remedial Work. All Remedial Work shall be performed by one or more contractors, approved in advance in writing by Mortgagee, and under the supervision of a consulting engineer approved in advance in writing by Mortgagee. All costs and expenses of such Remedial Work shall be paid by Mo tgagor, including, without limitation, the charges of such contractor and the consulting engineer, and Mortgagee's attorney's fees and costs incurred in connection with the monitoring or review of such Remedial Work. In the event that Mortgagor shall fail to timely commence, or cause to be commenced, or fail to diligently prosecute to completion such Remedial Work, Mortgagee may, but shall not be required to, cause such Remedial Work to be performed and all costs and expenses thereof incurred in connection therewith shall become part of the indebtedness secured hereby.
- (7) Without Mortgagee's prior written consent, which shall not be unreasonably withheld, Mortgagor shall not take any remedial action in response to the presence of any Hazardous Substance on, under, or about the Premises, nor enter into any settlement agreement, consent decrees, or other compromise in respect to any Hazardous Substance claim. Said consent may be withheld, without limitation, if Mortgagor in its judgment, determines that said remedial action, settlement, consent, or compromise might impair the value of Mortgagee's security hereunder; provided, however, that Mortgagee's prior consent shall not be necessary in the event that the presence of Hazardous Substances in, on, under, or about the Premises, either poses an immediate threat to the health, safety, or welfare of any individual or is of such a nature that an immediate remedial response is necessary, and it is not possible to obtain Mortgagee's consent before taking such action, provided that in such event Mortgagor shall notify Mortgagee as soon as practicable of any action so taken. Mortgagee agrees not to withhold its consent, when such consent is required hereunder, if either (a) a particular remedial action is ordered by a court of competent jurisdiction; or (b) Mortgagor establishes to the satisfaction of the Mortgagee that there is no reasonable alternative to such remedial action that would result in materially less impairment of Mortgagee's security under this Mortgage, the Mortgage Note and the Loan Documents specified therein.

(8) Mortgagor shall provide the Mortgagee, within fourteen (14) days after the Mortgagee's written request therefor, with (i) a written history of the Mortgagor's use of the Premises and the past use of the Premises, including in particular, but not in limitation, any past military, industrial, or landfill use of the Premises, and specifically indicating in such response the presence, if any, of underground storage tanks installed by Mortgagor or actually found and located by Mortgagor upon the Premises; (ii) if such underground storage tanks installed by Mortgagor or actually found and located by Mortgagor do exist, evidence of maintenance and repair thereof, copies of any and all clean-up or removal orders issued by any federal, state, or local governmental agency, and, if needed in the Mortgagee's judgment, evidence of removal of such underground storage tanks; and (iii) written indications from the regional office of the federal Environmental Protection Agency, and any state Environmental Protection Agency whether the Premises has been used for the storage of oil, hazardous waste, any toxic substance, or any Hazardous Substance.

For the purposes of this Paragraph, the following terms shall have the meanings as set forth below:

- (a) "Environmental Laws" shall mean any federal, state, or local law, statute, ordinance, or regulation pertaining to health, incustrial hygiene, or the environmental conditions on, under, or about the premises, including, vitabut limitation, the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as amended, ("CERCLA"), 42 U.S.C. Section 9601 et seq., and the Resource Conservation and Recovery Act of 1976, as amended, ("RCRA"), 42 U.S.C. Section 6901 et seq.
 - (b) The term "Hazardous Substance" shall include without limitation:
 - (i) Those substances included within the definition of any one or more of the terms "hazardous substances", "hazardous materials", "toxic substances", and "solid waste" in CERCLA, RCRA, and the Hazardous Materials Transportation Act, as amended, 49 U.S.C. Section 1801 et seq., and in the regulations promulgated pursuant to said laws or under applicable state law;
 - (ii) Those substances listed in the United States Department of Transportation Table (49 CFR 172.010 and amendments thereto) or by the Environmental Protection Agency (or any successor agency) as hazardous substances (40 CFR, Part 302 and amendments thereof);
 - (iii) Such other substances, materials and wastes which are or become regulated under applicable local, state, or federal laws, or which are classified as hazardous or toxic under federal, state, or local laws or regulations; and
 - (iv) Any material, waste, or substance which is (A) petroleum, (B) asbestos, (C) polychlorinated biphenyls, (D) designated as a "hazardous substance" pursuant to Section 311 of the Clean Water Act, 33 U.S.C. Section 1251, et seq. (33 U.S.C. Section 1321), or listed pursuant to Section 307 of the Clean Water Act (33 U.S.C. Section 1317); (E)

flammable explosives; or (F) radioactive materials.

- G. <u>ADDITIONAL COVENANTS</u>. (a) By February 28 of each year (or more frequently, if in the opinion of Mortgagee, Mortgagee requires the financial information specified in this subparagraph) while any portion of the indebtedness evidenced by the Mortgage Note is outstanding, Mortgagor shall provide Mortgagee with financial statements on forms to be prescribed by Mortgagee for Mortgagor and Guarantor.
- (b) For the year just immediately ended, Mortgagor shall provide Mortgagee with a rent roll of the Premises, which shall indicate the name of each tenant, annual and monthly rent for each leased space, percentage rent, if any, amount of space being leased, and the lease expiration date.
- (c) Mortgagor covenants not to alter, modify, amend, or change the terms of the Leases or give any content or permission or exercise any option required or permitted by the terms thereof or intentionally waive any obligation required to be performed by any of the parties thereto without the prior written consent of Mortgagee, or cancel or terminate any of such Leases, or accept a surrender thereof, except in accordance with the terms of the Leases, and Mortgagor will not make any further transfers or assignments thereof. Mortgagor further covenants to promptly deliver to Mortgagee, upon written request therefore, copies of any and all Leases, estoppel certificates in form and content satisfactory to Mortgagee signed by any of the tenants under the Leases, subordination and attornment agreements in form and content satisfactory to Mortgagee signed by any of the tenants under the Leases, and demands, claims and notices of default received by it from any parties to any of the Leases.
- 2. MORTGAGEE'S PERFORMANCE OF DEFAULTED ACTS. Upon the occurrence of an Event of Default, Mortgagee may, but need not, at any time after the giving of any notice and the lapse of any time thereafter which may be required by Paragraph 11 hereof, and subject to the provisions of this Mortgage make any payment or perform any act herein required of Mortgager in any form and manner deemed expedient by Mortgagee, and Mortgagee may, but need not, make full or partial payments of principal or interest or prior encumbrances, if any, and purchase, discharge, compromise, or settle any tax lien or other prior or junior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting the Premises or contest any tax or assessment. Such receiver shall have the power to take possession, control, and care of the Premises and to collect the rents, issues, and profits of the Premises during the pendency of such foreclosure suit, and, in case of a sale and a deficiency, during the full statutory period of redemption (provided that the period of redemption has not been waived by the Mortgagor), as well as during any further times when the Mortgagor, its heirs, administrators, executors, successors, or the assigns, except for the intervention of such receiver, would be entitled to collect such rents, issues, and profits, and all other powers which may be necessary or are useful in such cases for the protection, possession, control, wanagement, and operation of the Premises during the whole of said period, to extend or modify any then new lease(s) or management agreement(s), and to make new lease(s) or management agreement(s), which extensions, modifications, and new lease(s) or management agreement(s) may provide for terms to expire, or for options to lease(s) to extend or renew terms to expire, beyond the maturity date of the indebtedness hereunder, it being understood and agreed that any sucr lease(s) and management agreement(s) and the options or other such provisions to be contained therein, shall be binding upon Mortgagor and all persons whose interests in the Premises are subject to the lien hereof and upon the purchaser or purchasers at any foreclosure sale, notwithstanding any redemption from sale, discharge of the mortgage indebtedness, satisfaction of any foreclosure decree, or issuance of any certificate of sale or deed to any purchaser.
