The Focused Site Investigation & Remediation Objectives Report (March 16, 2006/Log No. 06/28763) and the untitled April 24, 2006 report (April 27, 2006/Log No. 06/29285), as prepared by Laicon, Inc. for the Dunton Court Cleaners property, have been reviewed by the Illinois Environmental Protection Agency ("Illinois EPA"). 
