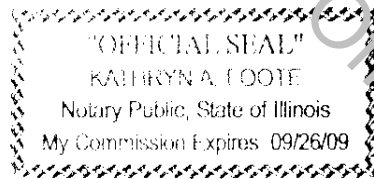

THAT PART OF THE SOUTH EAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 16 TOWNSHIP 42 NORTH, RANGE 9 EAST OF THE THIRD PRINCIPAL MERIDIAN, BOUNDED BY A LINE DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE EAST LINE OF SAID QUARTER QUARTER SECTION WITH THE NORTH LINE OF DUNDEE ROAD AS PER PLAT OF DEDICATION RECORDED DECEMBER 10, 1929 AS DOCUMENT 10550562; THENCE NORTH 00 DEGREES, 02 MINUTES, 45 SECONDS EAST ALONG THE EAST LINE OF SAID QUARTER QUARTER SECTION, 917.23 FEET TO THE NORTHEAST CORNER THEREOF; THENCE NORTH 89 DEGREES, 42 MINUTES, 45 SECONDS WEST, ALONG THE NORTH LINE OF SAID QUARTER QUARTER SECTION, 290 FEET; THENCE SOUTH 21 DEGREES, 11 MINUTES, 48 SECONDS WEST, 686.41 FEET; THENCE SOUTH BEING A LINE PARALLEL WITH THE WEST LINE OF THE SOUTH EAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 16, A DISTANCE OF 190 FEET; THENCE EAST 54.33 FEET; THENCE SOUTH 19 DEGREES, 54 MINUTES, 31 SECONDS EAST, 288.20 FEET TO A POINT ON THE NORTH LINE OF SAID ROAD, BEING A CURVED LINE CONVEX TO THE SOUTH AND HAVING A RADIUS OF 2242.01 FEET, A DISTANCE OF 426.80 FEET, ARC MEASURE TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS.
