FOSTER TO SWAN JOHNSON BY DEED DATED OCTOBER 4, 1898 AND RECORDED FEBRUARY 16, 1899 IN BOOK 6557, PAGE 624 AS DOCUMENT NUMBER 2785269 TO BE USED FOR ALLEY PURPOSES BY GRANTEE AND ABUTTING PROPERTY OWNERS JOINTLY; (2) BEGINNING AT A POINT IN THE WEST LINE OF SAID LOT 7, 12 FEET SOUTH OF THE NORTHWEST CORNER; THENCE EAST 50 FEET ON A LINE PARALLEL WITH THE NORTH LINE OF SAID LOT 7; THENCE SOUTH PARALLEL WITH THE EAST LINE OF SAID LOTS 7 AND 8 TO THE SOUTH LINE OF SAID LOT 8; THENCE WEST TO THE SOUTHWEST CORNER OF SAID LOT 8; THENCE NORTH ALONG THE WEST LINE OF SAID LOTS 7 AND 8 TO THE PLACE OF BEGINNING, EXCEPTING THEREFROM ANY PART THEREOF THAT FALLS IN THE EAST 10 FEET OF THE WEST 60 FEET OF THE SOUTH 33 FEET OF SAID LOT 8, IN COOK COUNTY, ILLINOIS.
