MODIFICATION OF MORTGAGE AND OTHER SECURITY DOCUMENTS

RECITALS:

WHEREAS, Lender has heretofore made a mortgage loan (the "Loan") to Mortgagor in the original principal amount of Three Million Nine Hundred Ten Thousand and 00/100 Dollars (\$3,910,000.00); and

WHEREAS, the Loan is evidenced by a Mortgage Note dated as of November _____, 2005 (the "Note") made by Mortgagor whereby Mortgagor promised to pay to the order of Lender the principal sum of Three Million Nine Hundred Ten Thousand and 01/190 Dollars (\$3,910,000.00), all as more specifically set forth in said Note; and

NCW, THEREFORE, for and in consideration of Ten and 00/100 Dollars (\$10.00) in hand paid, the musual covenants and conditions herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto do hereby agree as follows:

- 1. Incorporation of Recitals. The aforesaid recitals are hereby incorporated into this Modification by reference as if faily set forth in this Paragraph 1. Wherever the terms and conditions of this Modification coefficient with the terms and conditions of the Mortgage, the terms and conditions of this Modification shall control. In all other respects the parties do hereby ratify and declare to be in full force and effect the terms and conditions of the Mortgage and the Other Security Documents.
- 2. <u>Modification of Mortgage and Ctars Security Documents</u>. The Mortgage and Other Security Documents are hereby modified to provide that the Maturity Date shall be March 5, 2007.

From and after the date kereof (i) the Mortgage, the Assignment and the Other Security Documents shall be deemed to recure the Note as modified by the Note Amendment; and (ii) any and all references in the Mortgage or the Other Security Documents to the "Note" shall be deemed to refer to the Note as modified by the Note Amendment.
- 4. References to Loan Documents and Guaranty. Any and all references in the Note, the Mortgage and the Other Security Documents to the "Loan Documents" shall from and after the date hereof be deemed to refer to such Loan Documents as modified by this Modification: and any and all references in the Note, the Mortgage and the Other Security Documents to the "Guaranty" shall from and after the date hereof be deemed to refer to the Guaranty as modified by the Guaranty Modification.
- 5. Reaffirmation of Representations and Warranties. Mortgagor hereby reaffirms as true and correct in all respects, as of the date hereof, any and all representations and warranties contained in the Mortgage and the Other Security Documents.
- 6. Reaffirmation of Covenants. Mortgagor does hereby reaffirm and agree to perform all of the terms, covenants, conditions and obligations applicable to such parties as set forth in the Mortgage and the Other Security Documents as herein modified.
