Torgivable Loan Agreement

Loan Number NCH-06-02.

This LOAN AGREEMENT (the "Agreement"), dated as of October 16, 2006, by and between Nicolette Burin (the "Employee"), and Northwest Community Hospital at Illinois not-for-profit corporation having its business at 800 West Central Road, Arlington Heights, Illinois 60005, ("Participating Employer"), and North West Housing Partnership ("NWHP"), an Illinois not-for-profit corporation, having its principal office at 236 West Northwest Highway, Palatine, Illinois 60067.

Whereas, the Employer and Employee are mutually interested in the Employee's ability to own a home closer to the Employer's business location in the northwest suburbs; and

Whereas, the ability of the Employee to hold legal title to certain real estate (the 'Residence') described herein is dependent upon the down payment assistance of the employer, and the real estate is legally described and by this reference made a part hereof (the "Property"):

UNIT 22-356-A IN MERIBEL CONDOMINIUM IN VARIOUS PARCELS OF LOT 1 IN MARIBEL, A SUBDIVISION IN THE NORTHEAST QUARTER OF SECTION 24, TOWNSHIP 41 NOR TH. RANGE 9, EAST OF THE THIRD PRINCIPAL MERIDIAN, TOGETHER WITH ITS UNDIVIDED PERCENTAGE IN THE COMMON ELEMENTS ACCORDING TO THE DECLARATION OF CONDOMINIUM RECOPIED OCTOBER 14, 1992 AS DOCUMENT 92761699, AS AMENDED FROM TIME TO TIME, IN COOK COUNTY, ILLINIOIS.

P.I.N. 06-24-201-037-1201 , and commonly known as 356 Glen Leven Court, Schaumburg, IL 60194 ; and

Whereas, the NWHP has agreed to make a forgivable loan to the Employee (the "Loan"), to be used with such other monies as Employee may provide only to acquire the Property; and

Whereas, the Loan will be evidenced by a Promissory Note of even date herewith; and

Whereas, as an inducement to the NWHP to make the Loan, the Employee has agreed to enter into this Agreement in accordance with the terms, conditions and covenants set forth below.

NOW THEREFORE, the parties hereto covenant and agree as follows:

- 1. <u>Incorporation.</u> The foregoing recitals are made a part of this Agreement as fully and with the same force and effect as repeated herein at length.
- 2. <u>Terms.</u> The Loan shall not bear interest. The original principal amount of the Loan will be <u>Five Thousand and no/Dollars (\$5,000.00)</u>. The Loan will be subject to Recapture for a period of <u>five (5) years</u> beginning with the

date of this Agreement. On the anniversary date of this Agreement each month during the Recapture period, the amount of the Loan shall be forgiven and reduced by one-sixtieth (1/60th) for each full month of occupancy of the Residence, subject to the conditions in Paragraph 3 below. Employee shall be solely responsible for federal and/or state income taxes payable as a result of loan amounts forgiven.

- 3. <u>Restrictions.</u> As a condition of the provision of the Loan, the Employee agrees to repay the Employer the remaining portion of the Loan if any of the following occurs during the applicable Recapture Period for the Loan:
 - The Employee's relationship with the Participating Employer is terminated by either party;
 - A sale or transfer of the Employee's ownership interest in the Property occurs; or
 - The Employee no longer occupies the Property as the Employee's principal residence. Notwithstanding the foregoing, if the Employee dies before the expiration of the Recapture Period, payment of the remaining principal portion of the Loan shall be forgiven by the NWHP.
- 4. Violation of Agreement by Employee. Upon the Employee's failure to make any payment due under this Agreement, the NWHP may serve written notice thereof upon the Employee by registered or certified mail addressed to both the Participating Employer and the Employee at the address stated in this Agreement, or such other address as nay subsequently, upon appropriate written notice thereof to the NWHP, be designated. If payment is not made within thirty (30) days after service of notice, or such further time as the NWHP in its sole discretion permits, the NWHP may declare a default under this Agreement effective on the date of such declaration of default and notice thereof to the Employee, and upon such default the NWHP may:
 - (a) Declare the unforgiven portion of the Loan immediately due and payable; and/or
 - (b) Exercise such other rights or remedies as may be available to the Employer hereunder, at law or in equity.

The above remedies are cumulative and the exercise of one shall not be deemed an election of remedies, nor foreclose the exercise of any other remedies.

- 5. <u>Subordination</u>. Employer and Employee acknowledge and agree that this Forgivable Loan Agreement is subject and subordinate in all respects to the items, terms, covenants and conditions of the First Mortgage and to all advances heretofore made or which may hereafter be made pursuant to the First Mortgage including all sums advanced for the purpose of (a) protecting or further securing the lien of the First Mortgage, curing defaults by the Employee under the First Mortgage or for any other purpose expressly permitted by the First Mortgage or (b) constructing, repovating, repairing, furnishing, fixturing or equipping the Property. The terms and provisions of the First Mortgage are paramount and controlling, and they supersede any other terms and provisions hereof in conflict therewith.
- 6. <u>Termination of Restrictions</u>. In the event of foreclosure or deed in lieu of foreclosure of Prior Security Deed, any provisions herein or any provisions in any other collater it agreement restricting the use of the Property to low or moderate-income households or otherwise restricting the Borrower's ability to sell the Property shall have no further force or effect. Any person (including his successors or assigns) receiving title to the Property through a foreclosure or deed in lieu of foreclosure of a Prior Security Deed shall receive title to the Property free and clear from such restrictions.

Further, if any Senior Lien Holder acquires title to the Property pursuant to a deed in lieu of foreclosure, the lien of this Security Instrument shall automatically terminate upon the Senior Lien Holder's acquisition of title, provided that (I) the Lender has been given written notice of a default under the Prior Security Deed and (ii) the Lender shall not have cured the default under the Prior Security Deed within the 30-day notice sent to the Lender."

- 7. <u>Amendment</u>. The Agreement shall not be altered or amended except in writing signed by the parties hereto.
- 8. <u>Partial Invalidity</u>. The invalidity of any clause, part or provision of this Agreement shall not affect the validity of the remaining portions thereof.
- 9. <u>Gender</u>. The use of the plural in this Agreement shall include the singular; the singular shall include the plural; and the use of any gender shall be deemed to include all genders.
- 10. <u>Captions</u>. The captions used in this Agreement are inserted only as a matter of convenience and for reference and in no way define, limit or describe the scope or the intent of the Agreement.

12. Waiver of Jury Trial. The parties waive Trial by Jury in any action, proceeding or counterclaim brought by either of the parties hereto against the other on any matter whatsoever arising out of or in any way

connected with the Loan or this Agreement.
