SUPPLEMENT NO. 2 TO

DECLARATION OF CONDOMINIUM OWNERSHIP FOR THE RESIDENCES AT THE GROVE MIDRISE CONDOMINIUM

- 5. <u>Covenants to Run With Land</u>. The covenants, conditions, restrictions and easements contained in the Condominium Declaration, a amended by this Supplemental Declaration, shall run with and bind the Condominium Property, including the Added Property and Added Dwelling Units.
